The application must be accompanied by a 2,500 word paper in English on the following topic:

Artificial intelligence (AI) is being adopted widely across various sectors including in healthcare, finance and especially in content creation. Along with its benefits, the use of AI also gives rise to ethical, privacy and security concerns. How is the landscape of AI governance evolving in Asia and the Pacific, and what factors are shaping its development?



### **Criteria**

- 1. The Asia Pacific Regional Forum Scholarship to attend the **8th IBA Asia Pacific Regional Forum Biennial Conference: Vibrant Asia Land of opportunity and promise** from 19–21 February 2025 is free to enter. It is open to all lawyers up to and including the age of 35, practicing in an Asia Pacific country, whether or not they are members of the IBA.

- 3. Applications should be written in English and be accompanied by a 2,500 word paper on the following topic: **Artificial** intelligence (AI) is being adopted widely across various sectors including in healthcare, finance and especially in content creation. Along with its benefits, the use of AI also gives rise to ethical, privacy and security concerns. How is the landscape of AI governance evolving in Asia and the Pacific, and what factors are shaping its development?
  - Papers must be original, unpublished works. They will not be under consideration for any Commercial Contract by any publishing house. The author is warranting his/her restricted copyright to the paper submitted.
- 4. Applications must be submitted and received by **18 OCTOBER 2024**. Applications received after this time will not be considered.
- 5. All applications will be submitted to the Scholarship Committee which will consist of IBA Asia Pacific Regional Forum Officers. They will judge the papers primarily on the basis of legal argumentation, research, style, logic, originality and overall quality of the content.
- 6. It is planned that the IBA Office will communicate the conference selection panel decision to the successful applicant by **18 NOVEMBER 2024**.
- 7. The decision of the judging committee is final and no correspondence will be entered into. The decision will be published on the IBA website. The successful applicants will be contacted at the email address given on the application form.
- 8. The Scholarship Award includes:
  - Free registration for the **8th IBA Asia Pacific Regional Forum Biennial Conference: Vibrant Asia Land of opportunity and promise**, 19–21 February 2025, Hong Kong SAR, including social events; and
  - A contribution towards travel and accommodation costs to the conference.

- 12. Please note if you are awarded a scholarship you will be required to confirm your attendance by providing a copy of your travel documents for your flight to be booked and visa letter issued (should you need to apply for one). These documents must be sent to Joey Feng (joey.feng@int-bar.org) by 20 DECEMBER 2024.
- 13. The IBA has the right to publish a selection of the papers submitted, including but not limited to the winning paper (either the full text or extracts thereof) up to 18 months after the competition has ended; this includes but is not limited to the publication in the conference documentation and/or on the IBA website and/or other IBA publications. In any event, the name of the author will be indicated appropriately. Authors shall include a biographical note giving details of their legal career, studies and professional appointments. Papers received that are not in this form may not be considered.
- 14. If you are awarded a scholarship please note that proficiency in English is mandatory and you will be required to provide evidence that you are able to practise law.
- 15. Participants will be expected to have read and accepted all the above rules.
